

As local child care providers faced the coming fiscal cliff produced by the expiration of federal ARPA funds, Park City played an important leadership role
in stabilizing the provider base and ensuring upwards of 1/3 of our city's child care capacity did not simply evaporate. Going forward, the leadership
imperative for Park City is to bring together other governmental stakeholders, including the school district, to create a sustainable child care support
model for the area that focuses on both improving affordability and expanding capacity, while not simply replying on Park City taxpayers as a single-
source of funding for this critical regional issue.

As one of the city's housing policy liaisons and a vocal advocate for affordable housing, I am proud to have stood firmly in support of affordable housing efforts in town, including those of both the city and our non-profit partners. I believe our council's current development strategy favoring public-private partnerships – seeking out skilled partners versus taking on the role of developer ourselves – has been validated by the success of the 99-unit Homestake project and should remain a focus going forward. We must also focus further on driving down costs to deliver truly affordable projects that meet the needs of our workforce, and avoid projects that involve significant market-rate housing entitlements that simply create a need for even more workers.

The number-one social equity issue facing Park City is the availability of affordable housing — a need so enormous in scale that there is essentially no peer. This issue animated my five years of work on Planning Commission and my drive to serve on council for the past two years. I'm extremely proud of the city's successes in this area, but we have work to do in continuing to transition from a development mindset — simply building for-sale units — to a truly strategic mindset that looks to leverage every tool available to increase the share of housing that is affordable to Parkites, whether or not that involves putting a new unit in the ground. From policy changes, to long-term rental incentives, to better capturing federal rental assistance dollars, we must continue to develop a holistic strategy that addresses this critical need.
